## Further information on Gift Aid Declarations

Would you like to increase the value of your donation to the Hospice at **no cost to you and in a very simple way?** If so make a 'Gift Aid' Declaration!

### What is a 'Gift Aid' declaration?

IF YOU PAY TAX, the Inland Revenue will allow the Hospice to reclaim the tax that you have paid on your donation to us (28p for every £1 you give). This simply requires you to make a declaration that you have paid an amount of Income Tax (or Capital Gains Tax) that is equal to the tax that we will reclaim on your donation.

By making this declaration:

- \* You will **not** be involved in any administration or paper work - St. Luke's will do it all.
- \* You will **not** be committing yourself to make further donations to the Hospice - Gift Aid can apply to regular or one-off donations, however large or small.
- \* The Inland Revenue (Tax Office) will **not** become involved in your financial affairs - it is the Hospice that is accountable to the Inland Revenue.

### How do you make a 'Gift Aid' declaration?

It couldn't be easier. Either

- (a) sign the form of declaration overleaf and return it to St. Luke's Hospice - we will do the rest;
- or (b) just **tell us** that you are willing to do so (you can telephone us on 01268 272292 to do this) - we will then send you confirmation and you need do nothing more.
